PALMERSTON BREWERY.—The proprietor of the Palmerston brewery has decided to erect a large new malt house, independent of the one connected with the brewery. The new building will be 120 feet long, 90 feet wide, and 50 feet high, and will consist of four malting floors, with bonded warehouse above. In the rear will be an engine house, fitted with elevators for the barley, and other machinery will be 30 feet by 100 feet. The building will be commenced immediately, and large quantities of building materials are already on the ground. The capacity for malting will enable the proprietor to treat 200,000 bushels of barley in a season. Patent kilns and latest improvements will be adopted.
