The General Committee, entrusted in the month of February last with the collection and transmission of donations for the relief of destitution in Ireland, in now tendering an account of the trust reposed in them, beg to submit the following Report:

The Committee commenced by opening communication with the clergy of all denominations, as also with all magistrates, public functionaries, and other parties who from influence, station or property, would be likely to advance their object.

Aware, that however familiar residents in cities may be with Aware, that however familiar residents in cities may be with the daily accounts of increasing misery in Ireland, yet, that our rural population were, generally speaking, not conscious of the extent of the calamity, the Committee considered it their duty to give the widest circulation to those harrowing statements which reached them from the most authentic sources by every succeeding mail, each exceeding the former in its horrifying details, till humanity shrunk appalled from the contemplation of an extent of human suffering, which till then never shrouded the page of history. The Committee necessarily incurred some expense by this wide-spread correspondence, as well as from the printing and distribution of several thousand copies of extracts from English and Irish journals—expenses which, however, were amply repaid by the sympathies they awakened.

That the amount of subscriptions was large, beyond the most

That the amount of subscriptions was large, beyond the most sanguine expectation of the Committee, is not surprising, when we contemplate how deep, how heartfelt, and how universal the sympathies of all classes in the sufferings of the Irish people sympatities or all classes in the sufferings of the Irish people—sympathies which as freely poured forth their contributions from the limited means of the labouring classes as from the abundance of those whom Providence had more largely blessed; and as generously from those not allied to the sufferers, either in country or creed, as from those whose fondest recollections and most cherished hopes were linked in the fate of that unhappy
