Mr. REID:

1 and 2. Tenders per 2,000 pounds:

J. A. Boulay, Sayabec, \$1.05, delivered and packed in the icehouse, freight and all other charges paid.

J. H. Rioux, St. Fabien, 60 cents, f.o.b. cars, St. Fabien, railway to carry ice free of charge from St. Fabien to Ste. Flavie.

Ernest Dastous, St. Fabien, 64 cents for ice; \$1.40 for freight; \$2.04, packed in icehouse.

Sirice Rioux, St. Fabien, 591 cents, f.o.b. cars, St. Fabien, cars to be furnished free by the railway, and the railway to carry ice free of charge from St. Fabien to Ste. Flavie.

J. A. Pelletier, Rivière du Loup, 69¹/₂ cents, f.o.b. cars, Rivière du Loup.

3. The contract was awarded to Mr. J. A. Boulay at \$1.05, delivered and packed in the icehouse at Ste. Flavie, all charges paid, his tender being the lowest. The freight on a minimum car of 30,000 pounds from St. Fabien to Ste. Flavie is 6 cents per 100 pounds or \$1.20 per ton, which, added to Sirice Rioux's tender price of 591 cents, made his tender \$1.791 at Ste. Flavie.

PLAINFIELD POST OFFICE.
