whether it is his intention to make this information available to the house?

Hon. Robert Winters (Minister of Trade and Commerce): Mr. Speaker, a great deal of valuable information is being obtained. We are now learning more about the operations of subsidiary companies in Canada than we ever knew before. Much of the information is being submitted on the understanding that it will be kept private, in that it has a bearing upon the competitive position of the companies. The information is now being assembled, and to the extent that I can do so I will be glad to make it available to hon. members of the house when my estimates are under consideration.

Mr. Saltsman: A supplementary question, Mr. Speaker. In view of the great interest and the need of people carrying out studies of this kind in Canada, will this information be collected in a form that will be available to the economists who are working in this field?

Mr. Winters: To the greatest extent possible, consistent with the secrecy aspects of some of the information.

NATO—POSSIBLE CHANGE IN ROLE OF CANADIAN FORCES

On the orders of the day:

Mr. Andrew Brewin (Greenwood): Mr. Speaker, I had a question for the Secretary of State for External Affairs, who I see has left the house. I gave him notice of the question. I should now like to address it to the Prime Minister. In the light of the reported discussion between the President of the United States and the Chancellor of West Germany relating to a searching reappraisal of the threat to Atlantic security and the existence of a three nation—that is, American, German and British-study of changed force levels in NATO, does the Canadian government contemplate taking any steps to notify the representatives of these three governments of a desire to alter the future role of Canadian forces in NATO?
