VANCOUVER INTERNATIONAL—ROAD BUILDING AND RUNWAY EXPANSION—INTENTION AS TO MEETING WITH SEA ISLAND RESIDENTS CONCERNING COMPLAINTS

Mr. John Reynolds (Burnaby-Richmond-Delta): Mr. Speaker, my question is directed to the Minister of Transport. In view of the numerous pleas which were made to the Prime Minister and to the Minister of Transport, requesting their personal intervention concerning the problems inflicted on the residents of Sea island by the proposed road building and runway expansion at Vancouver International Airport, may I ask whether it is the intention of the Prime Minister or the Minister of Transport to meet personally with the people involved and investigate their charges of injustice and discrimination?

Right Hon. P. E. Trudeau (Prime Minister): I have had some exchanges with these people by way of correspondence, and so has the previous Minister of Transport. My recollection of the matter is that the representations made in their last letter to me had been sufficiently answered by the then Minister of Transport. A copy of the letter was sent to myself. I will check whether there has been any further arrival of representations to myself or to the Minister of Transport in recent weeks.

Mr. Reynolds: Would the Minister of Transport see fit to meet with these people before the meeting which is to be held on January 17 regarding access to the bridge, and would he also discuss at that time the meeting being held today in Vancouver concerning the airport?

Hon. Jean Marchand (Minister of Transport): If there are any complaints and anybody wishes to meet with me I will look into the file and be ready to arrange such a meeting if it seems useful.
