Capital Punishment

Motion No. 22.

That Bill C-84, An Act to amend the Criminal Code in relation to the punishment for murder and certain other serious offences, be amended by deleting Clause 8.

Mr. Speaker, with your leave and following a discussion with my colleagues from all the parties represented in the House about motions Nos. 21, 22 and 23.

Since these are technical motions concerning pleas, refusal to plead, allowing time, pleading over, and peremptory challenge, I will simply refrain from any comment on the matter. These subjects are very clear to the House, and I would rather hope the House would vote on motions 21, 22 and 23 in order to speed up the business of the House. We should prevent any unnecessary debate.

Motion No. 37

That Bill C-84 be amended in clause 21 by

(a) striking out lines 22 to 43 at page 8 and substituting the following therefor: $\,$

"669. The sentence to be pronounced against a person

(a) whose sentence of death is commuted to imprisonment for life or who is to be sentenced to imprisonment for life for an offence under subsection 214(3) or paragraphs 214(5)(b) or (c) shall be that he be sentenced to imprisonment for life without eligibility for parole until he has served twenty-five years of his sentence;

(b) who is to be sentenced to imprisonment for life for second degree murder, shall be that he be sentenced to imprisonment for life without eligibility for parole until he has served at least ten
