#### **REQUEST FOR AMENDMENT**

They cannot understand how justice is served when a 16 year old receives a three-year sentence for killing three people.

I urge the Minister of Justice (Mr. Lewis) to continue to pursue changes to the Act with his provincial counterparts. Public safety and justice demand nothing less.

# CLOSURE OF RURAL POST OFFICES

Mr. Joe Comuzzi (Thunder Bay—Nipigon): Mr. Speaker, the more than 5,000 rural post offices in Canada do more than provide mail service to our less populated and isolated areas. Those post offices, with their capable postmasters and staff, offer much to their communities. Rural post offices such as Nipigon, Red Rock, Armstrong, Dorion, Hurkett, and Murillo are meeting places for the residents. They assist people to complete government forms, monitor people who live alone, and provide other vital services to small communities.
