To the Free and Independent Electors of the County of Ottawa.

GENTLEMEN,—On the unanimous nominaon and at the urgent request of the deletes assembled in convention at the city of all, to select a candidate opposed the late ercier administration and in favour of the Bousterville Government, I have, alough reluctantly, accepted the position, dam now a candidate for your suffrages the present election of a representative the county of Ottawa in the Legislative esemb'y of the Province of Quebec.

If, as I have stated, I was unwilling to cept the nomination. it was not because 1 is insensible to the great honour conferred on me by the choice, but for personal asons which it is not necessary to state, I ould have preferred that some other dard-bearer should have been chosen; d were this a mere party contest I would ve probat v persisted in declining the nour. But on the result of this election e welfare of the Province, and particularly is district, so largely depends that I felt at my duty to my country required me to cede to the large and influential delegation o considered that under the present cirmatances I was the porson most likely to tain the support of the majority of the ctors of this large and populous constitu.

The astounding revelations which have led the displaced of Mr. Mercier and his colgues, the apponiment of a new ministry, i the present appeal to the people are too ll known through the length and breadth the Province to require recapitulation e, and have roused feelings of indignation I dismay, not only amongst Conservatives, also among those Nationalists and Lible, who had put in plicit confidence in the nesty end integrity of Mr. Mercier and associates, but who are shocked and reted by the frightful and increasing list of dling and lav shuess which the records every department of the Government are ablishing against him. To this is due the port which the new Government is receiving from thousands who were formerly adherents of Mr. Mercier. And to this I owe the declarations which many Liberals and Nationalists in this county have already made in my favor.

And I now take the opportunity of saying that on this occasion the electors will be divided by lines broader than those of party, namely, the line which saparates those who desire an honest and economical government and those who are willing to have a continuance of the extravagance and bondling which have characterized the administration of Mr. Mercier. Between those who desire such strict and honest administration of the finances of the Province as will reestablish the balance between revenue and expenditure and those that are willing that the same lavish course which operationed, in the last year & dencit of two million dollars, and in four years has added thirteeu millious of dollars to the debt. And in the midst of all this excessive expenditure and the boodling by which Mr. Mercier and his friends have enriched themselves, he found it expedient to reduce by six thousand dollars a year the grants to colonization roads in this county nor could be afford one cent to our cheese factories although he made grants to those in other counties. And upon these grounds I call upon the honest and intelligent electors in this county, without distinction of party, to assist, by electing me as a supporter of the deBoucherville Government, in bringing about that retrenenment necessary to save us from bankrnptcy and heavy direct taxation to which we were surely and rapidly drifting.

With respect to myself I have only a few words to say, for I feel that with the treremious issues involved in this contest, personal qualifications must be of small account, and should my opponent, be he who be may, be in many respects superior to me, that cursumstance should have little weight with the voters if he favors Mr. Mercier.

But this without vanity, I may say, in the day of trie and in the day of triumph, in storm or in sunshme, I nave been and I am . staunch though moderate Conservative, but if elected to represent you I s. all always remember that I owe my duty to my country first and to my party after. My nome and all I possess in the world are in the city of Hull and county of Ottawa; therefore the electors of that county need no assurances from me that I will do my best to promote our common interests. And in this respect a can assure the electors that from declarations made by members of the Boucherville ca binet that Government if sustained will so amend the tariff of timber dues as to reduce them at least to an equality with those of the Province of Outario; and will so change the laws with respect to mines and mining as to afford proper encourage. ment to prospectors and remove the present heavy burdens on the trade. And the peopl of the county should remember that these taxes aithough nominally imposed on the mberers' and miners' affect indirectly, the farmers and the working men for the more the manufacturers have to pay the government, the less they have to pay for labor and supplies.

I think I should here allude to a report which was circulated some time ago, and will probably be revived by my opponente, to the effect that I had signed the requisition for the calling out of the militia during the strike of the mill men last autumn. 1 give that statement my most unqualified demul. I never signed any such document nor took any part in invoking the aid of the military. Far from beingopposed to the working men. I am andhave always been their ilncere friend and if elected will do everything in my nower to promote their interests, and will assist in repealing the harrasving law passed by the Mercier Government, and supported by the vote of our late representative. I mean the law which allows the scizure of uncarned wages, and obliges the employer to go every month to court to make a new declaration so long as the defendant remain in his employ, and the debt and costs

are not entirely satisfied.

In conclusion I must solemnly pledge myself if elected that I will honourably and conscientiously, to the best of my shility do my duty to my country and my county.
