Wall Street Thinks Government May Extend Further Assistance.

New York, March 6.—Ralls and Steel shared the honors of today's desultory stock market, the former advancing one to three and a half points on intimations of early federal developments beneficial to the transportation systems, and the latter responding quite substantially to some very favorable exhibits of earnings.
