

W. SHIVES FISHER IS RE-ELECTED

Again Leads Assoc. Charities—M. E. Agar Scores Neglect of Poor.

The work of the Associated Charities in St. John, was presented at its annual meeting, last night, in the Board of Trade rooms, with W. Shives Fisher, president, in the chair. Not only in the report of the secretary, Miss Grace O. Robertson, but also in the addresses given by Miss D. Coates, M. E. Agar, president of the Board of Commissioners of the General Public Hospital, and Rev. J. V. Young, the meeting was given some realization of the distressing problems with which the society is called upon to deal.

Miss Robertson's report of 1,428 applications dealt with and was subdivided as follows: Seeking employment, 241; employment found for 174; seeking relief, 292; relief given, 273; seeking transportation, 21; transportation found for 21; night lodging provided for 14; seeking to have children adopted, 5; clothing given, 81; cases investigated, 99; visits made, 979; recommended, 264; records given, 184. She related some pitiable cases which were dealt with and explained how the association worked in co-operation with all the local agencies seeking to secure the general welfare of the people and help without injury to morale.

The gifts of friends made the contribution of funds and clothing possible for emergency relief. A clearing bureau was conducted at Christmas for distributing of Christmas cheer. The management of the Opera House, by giving a benefit night for the Associated Charities, brought \$264.65 to the funds. Miss Robertson closed her report by referring

SIMMONS ATTACKS WIZARD FOR HIDING

Emperor Calls Evans' Actions Cowardly in Present Crisis.

Atlanta, Nov. 14.—Col. William J. Simmons, Emperor of the Ku Klux Klan, said he was astonished that Imperial Wizard H. W. Evans should remain in hiding at a critical time like the present, and that newspaper men and Klansmen were unable to find any responsible head at palace headquarters willing to meet those entitled to information.

"I don't believe Klansmen of the nation are going to put up much longer with an administration that meets critical situations in such cowardly manner," the emperor said.

Dr. Fred B. Johnston, chief of staff to Emperor Simmons, who returned from Birmingham with his superior said he had gone to Birmingham to guard the emperor because of a "reliable tip that Simmons was to be removed via the murder route." He said numerous telephone calls had threatened the lives of Simmons, E. V. Clarke, Imperial giant, and himself.

Peace warrants against three of Evans' aids, dismissed here when Johnston failed to appear in court, will be released if the necessity arises, Johnston said. The warrant against Wizard Evans stands.

Developments growing out of the killing of Capt. W. S. Corman, Klan attorney, which brought tip the new situation within the Klan, were meager so far as they affected Philip E. Fox, Klan publicity man, under indictment for the murder of Corman. The State commented its efforts toward an early trial, while Mrs. Fox was on the work of slaying the defense.

Col. Simmons said he could not say whether he would aid the prosecution.

Commenting on the reported plot to assassinate Klan officials, the emperor said: "If I thought the one of those, whoever commits the deed will kill a friend and not a foe, for I hold no hatred or ill will toward any man woman or child."

J. F. BROWNE IS NAMED MUSICAL DIRECTOR OF SCHOOLS IN CITY

Many Matters of Interest Dealt With at School Board Session.

The appointment of J. F. Browne as director of musical instruction in the city schools at a salary of \$1,250 was approved by the meeting of the Board of School Trustees last night and the meeting also gave authority for the removal of a class now being conducted in the synagogue building to a room in the office building in order that a manual training class might be moved into the synagogue room. Much business was transacted at the meeting.

Rev. J. V. Young gave some special instances of very distressing relief cases. He found three reasons for poverty and these were unemployment, aloof and indifference to the needs of the poor in proper ways of managing was greatly needed and the supply of fuel and clothing was a problem that had to be faced. In closing Rev. Father Young paid a tribute to Miss Robertson's splendid work among the poor.

Mr. Fisher, Hon. R. J. Ritchie, a charter member, and Mrs. George F. Smith, voluntary aid societies, were present. Miss Stella Payson suggested that a greater effort should be made to get new subscribers.

POSSESSION CLAIM ADJUDGED INVALID

In the bankruptcy court yesterday afternoon, Chief Justice McKewen adjudged George R. Wetmore, proprietor of five "cash and carry" grocery stores here, bankrupt and appointed the Canadian Credit Men's Association permanent receiver. The court decided against the claim of Baird & Peters, Ltd., wholesale grocers, which took possession of Mr. Wetmore's stock recently under an agreement with him. It was contended by G. E. Harbottle & Co., Ltd., T. H. Estabrooks, Ltd., H. W. Cole and other wholesale dealers that preference had been extended by Mr. Wetmore to Baird & Peters, Ltd. The decision of the court means that Baird & Peters, Ltd., will occupy the same position as the other creditors.

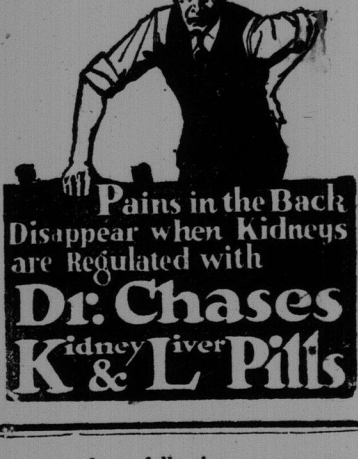
Mr. Wetmore's liabilities are placed at \$80,000 and the assets at \$16,000.
