MR. PIGGOTT'S ANSWER TO EGAN'S CHARGES.

PARIS, Dec. 10.—Piggott has written a letter denying Egans' charges that he endeavored to extort a loan by threatening to publish a statement relative to the alleged misdeeds of the league's funds. He maintains that it was the league which offered him \$5000 to publish false accounts. He commits severely on Egans' conduct and declares the non recti cry is an injury to Ireland and a libel on Irish patriotism.

Blair J. McNeill, publisher of a letter declaring that if the radical party does not compel Gladstone to reverse his policy and release the League, he will at the next general election. He says he will show the power of recently-completed Irish organization.
