MUCH EXCITEMENT IN PARIS

A Recent Interview with the Young Duke of Orleans.

Paris, Feb. 9.—In view of the escape of the young Duke of Orleans an interview with his father, the Count of Paris, just before the latter's departure for America will be interesting.

The Count said his object was to visit the West Indies, Canada and the United States.

"Do you think there will ever be a revolution in France?"

"Well, that depends upon circumstances. I, of course, hope there will be and I sincerely believe that if the question of establishing a monarchy were put to a vote the people would be heartily in favor of it."

"What do you think of Gen. Boulanger's chances of becoming president of France?"

"I think that Gen. Boulanger's absence from France will be a great misfortune."

"What do you hope to gain by General Boulanger's success?"

"I hope to convince the people by his government together with the present, that a republican form of government is not the best for France."

"What are some of these conditions?"

"First of all the people want universal suffrage, which no monarch should have."
