5. Since April 1, 1973, on what date or dates did Mrs. Sondra Gotlieb enter into a contractual arrangement with the Minister responsible for Multiculturalism or any other department, ministry or agency and, in each case (a) what was the name of the department, ministry or agency (b) what was the purpose of the contractual arrangement (c) what was the amount of money involved (d) what steps were taken to ensure that any copyright would be in the name of the Crown?—Sessional Paper No. 301-2/2,271.

Mr. Reid, Parliamentary Secretary to the President of the Privy Council, presented,—Returns to the foregoing Orders.

Notice of Motion for the Production of Papers No. 35, as follows:

That an Order of the House do issue for copies of papers, studies, reports and financial statements relating to the operation of Econair since its inception,

having been called was, at the request of the Honourable the President of the Privy Council (Mr. Sharp), transferred by the Clerk to the order of "Notices of Motions (Papers)" pursuant to Standing Order 48(1).

The Order being read for the second reading and reference to the Standing Committee on Agriculture of Bill C-53, An Act to amend the Prairie Grain Advance Payments Act, No. 2;

Mr. Lang, seconded by Mr. Basford, moved,—That the Bill be now read a second time and referred to the Standing Committee on Agriculture.

After debate thereon, the question being put on the motion, it was agreed to.

Accordingly, the Bill was read the second time and referred to the Standing Committee on Agriculture.

Bill C-50, An Act to amend the Agricultural Stabilization Act, as reported (with amendments) from the Standing Committee on Agriculture, was again considered at the report stage.

Whereupon, the House resumed debate on the motion of Mr. Horner, seconded by Mr. Howie,—That Bill C-50, An Act to amend the Agricultural Stabilization Act, be amended by deleting subclause 5(2) being lines 10 to 18 at page 4.

After further debate, the question being put on the motion, it was negatived, on division.

On motion of Mr. Whelan, seconded by Mr. Basford, the Bill, as amended, was concurred in at the report stage and ordered for a third reading at the next sitting of the House.

By unanimous consent, Bill C-62, An Act to amend the Old Age Security Act, to repeal the Old Age Assistance Act and to amend other Acts in consequence thereof, as reported (without amendment) from the Standing Committee on Health, Welfare and Social Affairs, was concurred in at the report stage.

Mr. Lalonde, seconded by Mr. Whelan, moved,—That the Bill be now read a third time and do pass.

After debate thereon, the question being put on the motion, it was agreed to.

Accordingly, the Bill was read the third time and passed.
