Inquiries of the Ministry

Mr. Hignett will be so; but it is not anticipated that such will be the situation.

Mr. Diefenbaker: Mr. Speaker, in view of the explanation given by the minister, does he agree that the president of Central Mortgage and Housing Corporation did predict that as many as 35,000 fewer homes would be built this year?

Mr. Speaker: Order. I suggest to the right hon. Leader of the Opposition that in the way in which the question is put now—whether the minister agrees that the statement was made—is not in a form which might be acceptable.

CONTROL OF IMPORTATION OF MISLABELLED FOREIGN DRUGS

Mr. A. D. Hales (Wellington South): Mr. Speaker, I have a supplementary question for the Minister of Industry. Can the minister say whether the Lucas Company, referred to by the hon. member for Simcoe East is the same company to which his Department of Industry gave tax concessions, if they would locate in the former depressed area of Windsor?
