LOWER ST. LAWRENCE-INQUIRY AS TO DEVELOPMENT PLAN

Hon. René Tremblay (Matapédia-Matane): Mr. Speaker, I would like to put a question to the hon. Minister of Forestry and Rural

Development.

Could the hon. minister tell the house when he is hoping to sign the agreement with the government of the province of Quebec, with respect to the implementation of the program for the development of the Lower St. Lawrence, Gaspé Peninsula and the Magdalen Islands?

Hon. Maurice Sauvé (Minister of Forestry and Rural Development): Mr. Speaker, if we can carry on our negotiations smoothly, I hope that in two months and a half to three months we will have the pleasure of signing this agreement.

Mr. Tremblay: I would like to ask a sup-

plementary question.

Could the hon. minister assure the house that this agreement will take into account the responsibilities and prerogatives of the federal government in this pilot territory?

Mr. Sauvé: Mr. Speaker, just as in any such agreement, the federal authorities will fulfil the duties devolved upon them, and the province will also assume the responsibilities under its jurisdiction.

Hon. Martial Asselin (Charlevoix): I would also like to ask the minister what is the share of the federal government in those agreements for the development of that area of the Gaspé Peninsula. Is it fifty-fifty with the province of Quebec?

Mr. Sauvé: Mr. Speaker, it varies according to areas. Up to now, in the three agreements signed, the federal contribution was 66 per cent and I think that in the case of the Development Bureau of Eastern Quebec for the Lower St. Lawrence area, the Gaspé Peninsula and the Magdalen Islands the federal government contribution will amount to approximately \$160 million out of a total amount of \$250 million.
