UNITED AIRCRAFT—CONTINUED TRANSFER OF PRODUCTION FROM QUEBEC TO UNITED STATES

Mr. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I ask leave under the provisions of Standing Order 26 to move the adjournment of the House for the purpose of discussing a specific and important matter requiring urgent consideration, namely the continuing transfer of production from the United Aircraft Corporation in Longueuil, Quebec, to the United States, such continuing action putting into jeopardy all future production in Longueuil and the wasting, therefore of over \$70 million of federal grants to that corporation.

Mr. Speaker: The hon. member was good enough to give the Chair the notice required by the rule two hours prior to the beginning of this morning's session. This has given the Chair the opportunity to consider whether the proposed motion comes within the provisions of Standing Order 26.

There can be no doubt, of course, of the importance of the subject matter of the motion. However, in addition to its urgency and importance hon. members will know that
