# Oral Questions ANTI-INFLATION BOARD

## NUMBER OF ADDITIONAL EMPLOYEES NEEDED TO COPE WITH INCREASED WORKLOAD

**Mr.** Sinclair Stevens (York-Simcoe): Mr. Speaker, my question is for the Minister of Consumer and Corporate Affairs. With estimates of his department already requesting nearly 400 employees to run the anti-inflation program, twice the original estimate of 200, will the minister tell the House how many additional staff members will be required by the Anti-Inflation Board in order to cope with the expansion of their activities announced in the order in council tabled yesterday which puts the number of firms covered by the board at 20 times the original estimate?

Hon. André Ouellet (Minister of Consumer and Corporate Affairs): Mr. Speaker, that question should be directed to the Minister of Finance.

Hon. Donald S. Macdonald (Minister of Finance): Mr. Speaker, I do not have a precise figure in that regard. I will see if I can seek one and communicate with the hon. member.

## POSSIBLE EXPANSION OF MONITORING ACTIVITIES— EXPANSION OF CONTROLS—POSSIBLE ADMISSION OF NEED FOR COMPREHENSIVE CONTROLS

Mr. Sinclair Stevens (York-Simcoe): Mr. Speaker, I would point out to the Minister of Consumer and Corporate Affairs that the estimates actually come under his department with respect to the Anti-Inflation Board. My supplementary question is to the Minister of Finance. Accepting that general insurance companies are now being reviewed with a view to possibly including those companies under the wage and price controls, will the minister tell the House whether the Anti-Inflation Board or he is considering any further expansion of monitoring and regulating activities into sectors of the economy as yet unaffected by the wage and price control program? Also, will he tell the House whether the expansion of the scope of the anti-inflation program represents an admission that selective controls are inadequate and a realization that comprehensive controls are more appropriate?

Hon. Donald S. Macdonald (Minister of Finance): Mr. Speaker, I wish to confirm that the Anti-Inflation Board will receive a reference from the government with respect to the general insurance industry. Of course, under the provisions of the law, that will be effective from the date of the public statement and the reference. The hon. member seems to be saying in one breath that the Board is acquiring too many personnel, while in the next breath he says it should engage in a program which would require many more personnel. I would have to reflect to see if there is any logic in the two positions.
