NATURAL GAS—REQUEST FOR REPORT ON PIPELINE FROM MELVILLE AND KING CHRISTIAN ISLANDS

Mr. Gérard Laprise (Abitibi): Mr. Speaker, my question is directed to the Minister of Energy, Mines and Resources.

As the federal government is the main shareholder in Panarctic Oil Company, can the minister tell the House whether the study on the right of way for the construction of a gas pipeline from the wells located on Melville and King Christian islands in the Arctic to eastern Canada has been completed, and whether he intends to present a report on the activities of that company with regard to natural gas?

INCARCERATION OF SHARON BETHUNE IN MEXICAN JAIL— REQUEST FOR REPORT ON ACTION TO OBTAIN RELEASE

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I should like to ask the Secretary of State for External Affairs a question which was put to him by the hon. member for Burnaby-Richmond-Delta and in respect of which I moved a motion today under Standing Order 43. What steps are being taken by the minister and his department in reference to the long incarceration of Sharon Lynn Bethune who is being held in deplorable conditions not fit for a human being in a Mexican jail and who is being held there even though her father has put up \$18,000, more or less, in order to have her released, but has been unable to obtain her release at this stage.

Hon. Donald C. Jamieson (Secretary of State for External Affairs): Mr. Speaker, I will give the hon. member as much information as I possibly can on this question bearing in mind, as I think he will realize, that perhaps too much public discussion of this matter may not be useful at the present time.

The situation is that we were advised by the young lady's lawyer in the early part of this week that she would be released in a couple of days. The lawyer subsequently has advised our embassy that in fact he was misinformed and that the judge decided to wait until early next week in order to consider the matter. The most recent assurance we have had is that the case will be considered next week and, presumably, if it is disposed of and results in Miss Bethune's release she will be free to
