In view of the fact that the commission of inquiry into air safety, in its investigation of 29 Twin Otter accidents in the last three years, is being impeded by the refusal to co-operate in providing information or documents by de Havilland Aircraft of Canada Limited, and in view of the fact that de Havilland is a federal Crown corporation, I move, seconded by the hon. member for Laprairie (Mr. Deniger):

That the Minister of Industry, Trade and Commerce, who is responsible to Parliament for the said corporation, instruct the officials of de Havilland to co-operate to the fullest extent with this very important commission.

CONDEMNATION OF CONDUCT OF VANCOUVER HOCKEY FANS DURING SINGING OF NATIONAL ANTHEM—MOTION UNDER S.O. 43

BRAND NAMES OF MARGARINES CONTAINING HIGH PERCENTAGE OF TRANSFATTY ACIDS—MOTION UNDER S.O. 43

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, several weeks ago the government refused to make public a federal government-commissioned study that lists the brand names of margarines that contain a high percentage of transfatty acids that are potentially dangerous for people with heart problems.

With the co-operation of the *Kitchener-Waterloo Record*, we now have access to a partial list, and in order to allay the fears of the public I move, seconded by the hon. member for Timiskaming (Mr. Peters):

That this House instruct the government to make public the entire list of the brand names of margarines found to have a high incidence of transfatty acids from the study called "Fatty Acid Composition of Margarines" conducted by Alpha Laboratories in Toronto and commissioned by the Canadian Dairy Commission.
