RECOMMENDATIONS OF MR. JUSTICE HALL—GOVERNMENT POLICY

Mr. Raymond Garneau (Laval-des-Rapides): Mr. Speaker, my question is directed to the Minister of Transport.

We know how important the grain transportation policy is to Quebec farmers and to producers in Western Canada. This morning the papers reported that the Government was going to wait at least a year before implementing the recommendations of the Hall Report. Hon. REQUEST FOR CLARIFICATION OF RECOMMENDATIONS

Mr. Raymond Garneau (Laval-des-Rapides): Mr. Speaker, considering the Minister's answer and the importance these decisions will have for producers in Quebec, Alberta, Saskatchewan and Manitoba, does this mean that the Hall recommendations will not affect Canadian producers, either in Eastern or Western Canada, before the 1987-88 season?

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, the recommendations that have been advanced have been advanced under a set of criteria with the one important criterion being the method of payment that will be the most conducive to agricultural development in Canada and, second, a method of payment that will not be unfair or disproportionate to sectors of western agriculture relative to other regions of the country.

INDEXATION OF PENSIONS—MINISTER'S POWERS

Mr. Mike Cassidy (Ottawa Centre): Mr. Speaker, I have a question for the President of the Treasury Board. It concerns the grave misgivings that members of the Public Service, the unions, and also superannuated members of the Public Service are expressing over the announcement that the Government is proposing to deindex public service pensions. The agreement with the alliance states that pension adjustments for inflation, and I quote: "will be determined by the President of the Treasury Board on the basis of the recommendations of the management board", that is the union-employer management board that is being proposed.

Is the Government proposing that the Minister will be able to veto or to change recommendations of that management board on inflation adjustment? If so, why should the public service unions give up the statutory indexing they now have, for a grace and favour system which gives the power to the Minister?

Hon. Robert de Cotret (President of the Treasury Board): Mr. Speaker, let me say that first it is an agreement in principle. It is a basis for negotiating the final agreement that we can reach with both parties on the issues of pensions.
