I therefore submit this bill in the hope that the House, in its wisdom and concern for justice, see fit to repeal an unjust and unjustifiable provision of the Canada Post Corporation Act.

PETITIONS

GOODS AND SERVICES TAX

FISHERIES

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, I rise again today on a matter that is a multicultural issue as well as an economic issue that affects in particular the Chinese community in British Columbia and perhaps other parts of Canada as well.

It concerns the dwindling stocks of live rock codfish which is a commodity of high cultural and economic value to Asian Canadians. It also serves many tourists and is a staple fresh food that is always in demand by families in restaurants.

People are very concerned that the sports fishery is overfishing this type of fish in that there is a very limited season for the Chinese community. They ask that the federal government change its policies and overcome the negligence toward the live rock cod fishery so that it will be available on a year-round basis to some 200,000 Canadians of Chinese descent who live throughout the lower mainland. They want to ensure that a year-round supply of live rock cod is available.
