Hon. Mitchell Sharp (Secretary of State for External Affairs): I thank the hon. gentleman for asking this question. I was about to rise and endeavour to catch your eye, Mr. Speaker, so that I might answer it. The Canadian position will be outlined in more detail at the conference which is now proceeding in Geneva, but I can assure the hon. member that we welcome the British initiative in the search for supplementary measures which will strengthen existing agreements and preclude the use of chemical and biological agents in warfare.

Mr. Lewis: In view of reports, which had not reached my notice when I first asked this question, that the British proposal relates only to biological warfare and does not concern chemical warfare weaponry, will the minister instruct our representative in Geneva to insist that chemical warfare be included as part of the agenda for discussion and in the eventual protocol?

Mr. Sharp: One of the reasons I did not go further in supporting the British initiative is that in our opinion it does not go far enough. It would be our intention to press for even stronger measures in both the chemical and biological fields.

Mr. Lewis: Can the minister make certain that members of this house obtain as quickly as possible a copy of the statement to be made by Mr. Ignatieff, I imagine, at the conference on this subject?

Mr. Sharp: To the extent that it is not a confidential document, I shall endeavour to do so.
