gust 1944 he was posted to Prince Albert Detachment on general police duties. Three years later he was returned to Prince Albert Sub-Division HQ as a crime reader. He was promoted to the rank of corporal on November 1, 1947. In January 1948 he was transferred to "F" Division HQ, Regina, where he was made i/c of the "F" Division "Youth and the Police" programme. Throughout his service in the Force, he was recognized by the community for his dedicated involvement with youth and the Boy Scouts Association of Canada. Over the years he received laudatory remarks from both individuals and the local media in this regard. BROOKSBANK Reg. No. S/9817, ex-S/Cst. Lawrence Herbert Brooksbank, 80, died on March 29, 1984, at Winnipeg, Man.

BROUGH Reg. No. 11209, ex-Sgt. John Lawrence Brough, 77, died on March 27, 1984, at Regina, Sask. Born on September 15, 1906, at Spry, Ont., he joined the RCMP on November 18, 1931, at Regina. Upon completion of recruit training at Depot, he was stationed at "F" Division, where he remained throughout his service. He performed general investigation and detachment duties at various locations, including Regina Town Station, North Battleford, Turtleford, Maidstone and Wilkie. He was later made i/c of Glaslyn, Goodsoil, Cut Knife, Macklin, Maidstone and Meadow Lake Detachments. In September 1954 he was appointed Section NCO North Battleford Sub-Division, his last post before retiring to pension on November 17, 1956. He had been promoted to corporal on November 1, 1945, to sergeant on November 1, 1953, and had been awarded the RCMP Long Service Medal, bronze clasp and star.

BROWN Reg. No. 20902, ex-Sgt. Archibald Douglas Brown, 71, died on January 20, 1984, at Regina, Sask. He was born on August 29, 1912, at Winnipeg, Manitoba, and joined the RCMP on August 1, 1953, at Winnipeg, as an armourer. He spent his entire service at Depot Division. The first six years he served as a special constable. On March 31, 1959, his status was changed and he became a regular member. On May 1, 1961, he was promoted to corporal and on November 1, 1967, to sergeant. He retired on January 1, 1970.

CAVILL Reg. No. 10767, ex-Sgt. Charles Herbert Cavill, 78, died on April 14, 1984, at Penticton, B.C. Born on September 6, 1905, at Portishead, Bristol, England, he immigrated to Canada in September 1925, and engaged in the Force on March 24, 1930, at Lethbridge, Alta. After recruit training at Depot, he was posted to "F" Division, where he spent most of his service. For two years, he performed general police and criminal investigation duties at Weyburn, Assiniboia and Omega Detachments. He was later made i/c of the following detachments: Wood Mountain, Assiniboia, Bengough, Weyburn, Fillmore, Milestone and Carlyle. In April 1949 he was posted briefly to Depot as a lecturer. Three months later he was transferred to "F" Division C.I.B. HQ, as reader i/c Criminal Code Office. In April 1952 he was made NCO i/c Moose Jaw Detachment. his last posting before retiring to pension on October 19, 1953. He had been promoted to corporal on April 1, 1941, and to sergeant on June 1, 1947, and had been awarded the RCMP Long Service Medal.

CHISHOLM Reg. No. 0.334 Insp. William Colin Vincent Chisholm (rtd.), 83, died on October 10, 1983, at Beverley Hills, California. He was born on July 27, 1900, at Antigonish, N.S., and joined the RNWMP on July 24, 1919, at Campbellton, N.B., with regimental number 8461. For a short time he worked as a clerk in Depot and "N" Divisions until October 20, 1920, when he purchased his discharge. He reengaged in the Force on June 1, 1921, at Ottawa, Ont. He was posted briefly to HQ Division, Quebec District, and "N" Division, Rockcliffe, before being transferred to "O" Division in March 1923. He worked as a teamster at Haileybury Detachment, after which he was posted to Toronto. He was later made i/c of Niagara Falls Detachment, where he worked as a chauffeur and performed general investigation duties. He was also made i/c of Moose Factory Detachment. On May 31, 1929, he took his discharge from the Force upon expiration of his term of engagement. He reengaged in the Force at Toronto on November 9, 1931, having served in the Ontario Provincial Police in the interim period. He served in "O" Division, where he was appointed i/c of Muncey Detachment, and later of St. Thomas and Sarnia Detachments. In June 1938 he was transferred to "F" Division, where he assumed command of Hanley Detachment, and then of Moose Jaw Detachment. In November 1942 he was posted to "D" Division, Winnipeg, and was made O.I.C. Interior Economy Branch. The following month, he was awarded the RCMP Long Service Medal. In July 1944 he was transferred back to "F" Division, North Battleford Sub-Division. In June 1946 he was posted to "K" Division, Edmonton, Interior Economy Branch. In February 1952 he was trans-
