STATIONS FROM AND TO WHICH TARIFF APPLIES

Fares and arrangements authorized in this tariff apply from Duluth, Minn., to destinations in Alberta, Manitoba and Saskatchevan. Destinations are arranged in alphabetical order by railways and provinces on pages 3 to 7.

Section 3

APPLICATION OF FARES

The fares shown herein on pages 3 to 7 are quoted in dollars and cents and apply for one-way second class tickets from and to the points named, and cannot be applied from or to other stations.

Section 4

LIMITS AND STOP OVERS

Tickets will be at transit limit of ten (10) days from date of sale and stop overs within transit limit will be allowed at intermediate points on application to Conductors. Days limit shown is in addition to date of sale. Journey must commence on date of sale.

Section 5

EXTENSION OF LIMIT ACCOUNT SICKNESS, ETC.

The time limit of tickets sold at fares quoted herein may be extended, and stopover will be permitted at intermediate points, in cases where illness renders it dangerous for a passenger to travel, or quarantine regions prevent the completion of the journey. Such privileges will be granted on the Canadian Northern Railway and Duluth, Winnipeg & Pacific Railway as shown in Can. Nor. By Circular No. 1383, LCC, No. 170, C.R.C. No. W. 988, supplements hereto or reissues thereof, and on other lines participating in this tartiff as shown in the tartiffs of those lines, as lawfully on file with the Interstate Commerce Commission.

Section 6

CHILDREN

For children of five and under twelve years of age, one-half of the fares quoted herein will be made, sufficient to be added where necessary to make the fare end in "0" or "5." Children under five years of age, when accompanied by an adult, will be carried free. Sub, contract and all coupons of tickets sold to children of half-fare age must be faced or punched "one-half."
