The evidence for the prosecution in the Hyams' murder trial has at last been placed before the jury, and when court adjourned last evening, the defence was fairly begun. The only incident worthy of note in the closing of the Crown's case was the production of the proofs of death sent to the New York Life by the friends of young Wells. One of the demands of this company is that proof papers in all cases shall be accompanied by a sworn statement by an uninterested householder, who is acquainted with the facts connected with the death of the subject of the policy. In this statement by H. T. Hyams he swears that he was in no way interested in the policy. The jury will be asked by the Crown to reconcile, if possible, this deposition with the fact admit-ted by the defence that before Harry Hyams married Martha Wells in May, he had obtained \$8500 of the money paid on the policy in which he was not interested.
