## Football Reunion

Old "Rangers" Banquet the W. F. A. Champions

THERE was a unique, sociable gathering of football men—present stars and old veterans of the great game—in the Walper House Saturday evening, when the Berlin team were the guests of the old "Rangers" at a banquet. It was a happy thought, and will revive a new interest in this the only sport that has retained its purely amateur standing.

The dinner was one done up by Mr. Davey's best style, and such as for which the Walper is noted, and was discussed with zest by the leather-chasers—old and young. The "Rangers" held their own, and at half-time were fresh and strong for the fray. President Mueller of the W. F. A. was absent through illness, and he was missed. Mr. D. Forsyth, the veteran footballist and Secretary of the Association, occupied the chair and referred the game. Among those noticed at the board were Messrs. Boehmer, Ehr, Gibson, Vogelstein, Roddella, C. Meike, Scher, H. Meike, Strick, of the champions; H. J. Sims, the redoubtable goal man of the present eleven and an old Ranger, and veterans: Bubacher, Sheppard, Dr. Bowly, G. D. LaCourse, Tony Kolb, Hueschgard and Uley. Several letters of regret were read from old timers who were unable to be present.

After punishing the good things provided, as only healthy football players can, the father of the game, Mr. Forsyth, called "Time" and asked the gathering to drink a toast to Her Majesty. This was done to the Queen's toast, after which the health and success of "Our Guests, the W. F. A. Champions," was proposed, and replied to by Messrs. Sims, Boehmer and Roddella who referred to the game played that day, the contention of the men after Thursday's game and the future of Association football in this, its cradle. Mr. Sims being the connecting link between past and present Berlin eleven, made numerous happy references and dwelt on the sinucous of a goal-keeper's position. He is a popular player and his oratorical bent once took well.

The Chairman's next toast was to "Competition" coupled with the names of Mr. Sheppard, Dr. Bowly and Mr. Bubacher. Mr. Sheppard's remarks were valuable in their suggestions as to the need of combined play on the forward line and the defence, while his comparisons of the game as played to-day with that played nearly a quarter of a century ago, were interesting to all.

"Solly" sang a topical song that the old players had heard on many a memorable occasion and which was received with hearty applause. The greeting he received betokened his great grip on the respect of all football men.

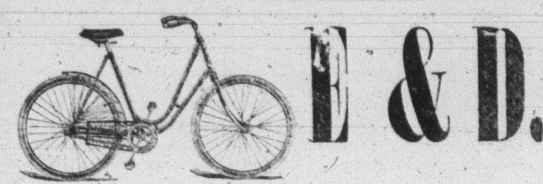
Dr. Bowly recounted of famous struggles in the early eighties, and told in an interesting manner of never to be forgotten struggles with Galt for championship honors, when the Association game was at its high tide of popularity. During these recitals, matters of date and detail were frequently referred to the Chairman for decision, and it being an informal gathering, he would call up twenty points in short speeches full of reminiscences, interesting alike to those who had gone through the noted battles on the football green as to those who hope to emulate the deeds of Berlin's football nobles.

After the Doctor's speech, Mr. Fred Boehmer proposed the health of the "Old Timers" and asked for replies from the Chairman and Messrs. Hueschgard, Kolb and Uttley. More football lore followed. That from Mr. Forsyth, who has led so many victories, some of them ferocious blows, to victory both at home and abroad, was listened to closely. He was warmly received, and at every mention of famous players, from Solly down, he was greeted with an ovation. Every person present being a player or an ex-player, could not get enough of the old stories, and as the hour of midnight stole upon them, they drank a toast to "Departed Players" and then formed a resolution that the "Rangers' Reunion" be made an annual affair, which will be carried out.

It was a gathering of deepest enjoyment to football men, and is worthy of reputation. It will serve to awaken a greater interest in the many old games, and by congregating the old warhorses and fighting old lights over again, friendships will be revived and strengthened, and something done to stem the tide of professionalism that is creeping into all outdoor games and which threatens to destroy the spirit of true sport, to the injury of coming manhood.

TECUMSEH BEAT TWIN-CITY. Toronto Globe.—Waterloo, July 3.—The Tecumsehs of Toronto and the Twin-City Lacrosse Clubs crossed sticks here this afternoon. Owing to the failure to produce the widely advertised match between the two teams on Jubilee Day the Celebration Committee decided to live up to their advertisement, and went to the great expense for the game to-day, allowing the public free admission. The game started at 3:30 and was a good exhibition of lacrosse, although it was easily seen after a few minutes' play that the undefeated Twin-City had met their superiors. The Tecumsehs by good combination succeeded in winning by 7 to 2. Nearly 1,000 persons witnessed the game. The weather was exceedingly hot, the temperature being over 95 degrees.
