Hon. E. J. Benson (Minister of National Revenue): (Prior to the 1962 taxation year the records of the Taxation Division did not provide this specific information.) Unclaimed amounts deducted for 1962 taxation year, \$48,392,287.80; unclaimed amounts deducted for 1963 taxation year, \$45,871,907.74.

The figures for the 1964 taxation year will not be compiled until early in 1966.

Mr. Jean-Charles Cantin (Parliamentary Secretary to Minister of Transport): Only one tender was received and order awarded to Raymond M. Parker & Company Limited, Saint John, N.B., who quoted f.o.b. departmental wharf Saint John, N.B., sales tax exempt for 30 tons hard coal (American nut or equal) bagged at \$33 per ton for \$990; 75 tons soft coal screened (Dominion Sydney or equal) bagged at \$22 per ton for \$1,650; 2 tons Blacksmith coal (Bulk) at \$26 per ton for \$52.

The total amount of the order is \$2,692.

ELDORADO MINING AND REFINING LTD.

Question No. 283-Mr. Caouette:

In addition to mining operations, what are the functions of Eldorado Mining and Refining Limited? [Translation]

Hon. Mitchell Sharp (Minister of Trade and Commerce): Eldorado Mining and Refining Limited, in addition to its mining operations, operates a refinery for the production of nuclear grade uranium oxide from mine concentrates, and the refinery also produces a series of other uranium products, using the nuclear grade oxide as a basis. The refinery is also prepared to process enriched uranium for the production of nuclear fuel for reactors. It is also engaged at present in pilot plant runs leading to the production of cobalt and silver from mine concentrates or speiss received from cobalt-silver producers in Canada: and to the production of zirconium sponge, a product used in nuclear fuels.

The company has also functioned as the government's agent for the purchase of uranium concentrates from other Canadian mines, either for resale to other countries under contracts negotiated by Eldorado, or as a part of a government stockpiling program.
