## YOUTH

OPPORTUNITIES FOR YOUTH PROGRAM—REQUEST FOR STATEMENT ON GRANT DISTRIBUTION AMONG INCOME CLASSES—CONSULTATION ON WEEKLY PAY RATE WITH PROVINCES

Mr. Cyril Symes (Sault Ste. Marie): Mr. Speaker, my question is addressed to the Secretary of State. Will the minister make a statement on motions outlining what measures the government has taken to ensure a more equitable distribution of the benefits of opportunities for youth grants among the youth of various income classes? In particular, what criteria are employed to guarantee that an adequate allocation of funds goes to youths of low-income families?

Hon. James Hugh Faulkner (Secretary of State): Mr. Speaker, I am not sure I will do that by way of a statement on motions—

Mr. Faulkner: —but I would like to elaborate on this. The two points raised by the hon. member are important. It was one of the strengths of the opportunities for youth program in the past that it did get to low income and remote areas. I would like to find some method of providing some information to the House.

Mr. Speaker: Perhaps we might allow the hon. member for Sault Ste. Marie a supplementary. The Chair will then recognize the hon. member for York-Simcoe and then call orders of the day.

Mr. Symes: Will the Secretary of State inform the House whether he had any consultation with the provincial ministers responsible for post-secondary education about the financial requirements of students before he determined the weekly pay rate under the opportunities for youth program recently announced?

PICKERING TOWNSHIP SITE—POSSIBILITY OF USE OF LAND TO BE EXPROPRIATED FOR LAND BANK RATHER THAN AIRPORT

In view of widespread interest in the proposed Pickering airport, will the Minister of Transport inform the House whether the government now intends to use the lands which are under notice of expropriation in the Pickering area for a land bank rather than for the proposed second Toronto airport?
