REDUCTION OF TARIFF ON BICYCLES—EFFECT ON INDUSTRY AT RIVERS, MANITOBA

No decision has been made about duty. I should point out that some changes in sales tax regulations will be of benefit to the company and may offset to some degree the effects of the decline in the rate of duty.

STEEL—GOVERNMENT ACTION TO DETERMINE IF PRICE INCREASES RELATED TO COSTS

In view of the conclusion reached by Judge Estey in the steel price inquiry that "any future price increases should be linked directly to cost increases, otherwise the profit margins which customarily obtain in the industry will be exceeded", and in view of the announcement by the steel companies this week of further price increases ranging from seven to twelve per cent in the case of certain products, has the government conducted an investigation to determine whether these increases are directly related to costs, and, if not, why not?

Right Hon. P. E. Trudeau (Prime Minister): I am sure this is the kind of question I would have referred to the parliamentary secretary had I been given notice of it. His minister is presently meeting with the Prime Minister of Iran. This is not the kind of question to which I have the answer in my head, and I think the House should realize that. If I had answered the question I would have answered it in exactly the same way as the parliamentary secretary did.
