INQUIRY WHETHER QUEBEC PERCENTAGE OF GASOLINE TAX IS GREATER THAN PERCENTAGE COLLECTED BY ALBERTA

**Mr. Jean-Guy Dubois (Lotbinière):** Madam Speaker, my question is directed to the Minister of Energy, Mines and Resources. In view of the present situation in Quebec with respect to gas and gas retailers, many Quebecers are wondering what share of the price of gas at the pump goes to the province of Quebec, and I would therefore like to ask the

minister for details about the percentage collected by the province of Quebec, and whether it is true that the percentage collected by the province is higher than that collected by the province of Alberta.

**Hon. Marc Lalonde (Minister of Energy, Mines and Resources):** Madam Speaker, the difference between the price of a litre of gas in New Brunswick and Ontario and the price of the same litre of gas in Quebec is now approximately seven cents, which means that in Quebec, a litre of gas costs about seven cents more. Regarding the percentage collected by the province of Quebec, it is not only more than that collected by the government of Alberta, it is more or less equal to the sum of the percentages collected by the government of Alberta and the federal government. In March, the government of Quebec was collecting 27.7 per cent on the price of gas, while the government of Alberta and the federal government collected a joint total of 28.2 per cent. Therefore, the government of Quebec is taking a very sizeable share of the price per litre. In fact, this percentage is higher than that taken by any other province in Canada.

**INCOME TAX**

COLLECTION OF DEDUCTIONS AT SOURCE FROM FISHERMEN

**Mr. Mel Gass (Malpeque):** Madam Speaker, my question is directed to the Minister of National Revenue. I realize that today may not be a very good day to ask him for favours.

**Mr. Nielsen:** He is cantankerous?

**Mr. Gass:** My question to the minister concerns the policy announced by the government of income tax deduction at source as it applies to fishermen, and the fact that the fishermen are the only small independent business persons who are asked to pay income tax in advance when they sell fish to the packers.

We met for two days last week with groups of fishermen from all over Prince Edward Island. Their main concern was income tax deductions at source. I want to ask the minister has there been any recent discussion on the mandatory policy of income tax deductions at source as it applies to fishermen in Atlantic Canada.

**Hon. William Rompkey (Minister of National Revenue):** Madam Speaker, that is a budget provision. The Minister of Finance announced it in the budget, as you know. The reason for announcing it was that I, among other people, had requested that he review this. The reason I did that was that a request came from the fishermen.
