### BY-LAW No.

A By-Law to aid and assist the Toronto, Grey and Bruce Railway Company, by giving \$250,000 to the Company by way of bonus, and to issue debentures therefor, and to authorize the levying of a special rate for the payment of the debentures and interest.

WHEREAS, by the Act of the first session of the Legis W HEREAS, by the Act of the first session of the Legislature of the Province of Ontario, passed in the thirtyfirst year of Her Majesty's reign, incorporating the Toronto,
Grey and Bruce Railway Company, it is provided as follows: "And it shall further be lawful for any Municipality
or Municipalities through any part of which, or near which,
the Railway or Works of the said Company shall pass, or
be situated, to aid and assist the said Company by loaning
or gharanteeing, or giving, money by way of bonus or other
means to the Company or issuing Municipal Bonds to or in
aid of the Company, and otherwise, in such manner, and
to such extent, as such Municipalities, or any of them,
shall think expedient; provided always, that no such aid,
loan, bonus, or guarantee shall be given except after the
passing of by-laws for the purpose, and the adoption of
such by-laws by the ratepayers, as provided in the Railway
Act."

And whereas, by the seventy-seventh section of the Rail-And whereas, by the seventy-seventh section of the Railway Act, chapter, sixty-six of the Consolidated Statutes of the late Province of Canada, it is provided that no Municipal Corporation shall subscribe for stock, or incur any debt or liability, under the said Railway Act, or the Special Act, unless and until a By-law to that effect has been duly made and adopted, with the consent first had of a majority of the qualified electors of the Municipality in the manner determined by the By-law, after public advertisement thereof containing a copy of the proposed By-law, inserted at least four times in each newspaper printed within the limit of the Municipality, or if none be printed therein, then in some one or more newspapers printed in the nearest city or town thereto, and circulated therein, and also put up in at least four of the most public places in each Municipality.

And whereas the Municipality of the Corporation of the City of Toronto has determined to aid and assist the said Toronto, Grey and Bruce Railway Company by giving thereto the sum of \$250,000 by way of bonus, under the authority conferred by the said Act first in recital.

And whereas, to carry the last recited object into t is necessary for the said Municipality to raise the um of \$250,000, in the manner hereinafter mentions

And whereas it will require the sum of \$27,500 raised annually by special rate for paying the said d \$250,000 and interest on the debentures to be issued for as hereinafter mentioned.

And whereas the amount of the whole ratable proper of the said Municipality, irrespective of any future increased the same; and also irrespective of any income to derived from the temporary investment of the sinking for hereinafter mentioned, or any part thereof, according to last revised assessment roll of the said Municipality, befor the year one thousand eight hundred and sixty-eights.

And whereas the amount of the existing debt of the said Municipality is the sum of \$2,144,853 44.

And whereas, for paying the interest and creating an equal yearly sinking fund for paying the said debt of \$250,000, as hereinafter mentioned, it will require an equal annual special rate of one mill and one-eighth of a mill in the dollar, in addition to all other rates to be levied in each

Therefore the Council of the Corporation of the City of ground enact as follows:

I. That it shall and may be lawful for the said Mur pality to aid and assist the Toronto, Grey and Bruce I way Company, by giving thereto the sum of \$250,000 way of bonus.

way of bonus.

II. That it shall be lawful, for the purpose aforesaid, for the Mayor of the said City to cause any number of debenures to be made for such sums of money as may be required for the said purpose, not less than twenty dollars each, and not exceeding in the whole the amount of \$250,00°, which said debentures shall be sealed with the seal of the said City, and be signed by the Mayor and Chamberlain thereof.

III. That the said disbentures shall be made payable in twenty years from the day hereinafter mentioned for this By-law to take effect, at the Bank of Toronto, in Toronto, and shall have attached to them coupons for the payment of interest at the rate and in the manner hereinafter mentioned.

IV. That the said debentures will bear interest at and after the rate of six per cent, per annum from the date thereof, which interest shall be payable half-yearly on the first day of May and November in each year, at the Bank of Toronto, in Toronto.

V. That for the purpose of forming a sinking fund for payment of the said debentures, and the interest thereon, at the rate aforesaid, an equal special rate of one mill and one-eighth of a mill in the dollar shall, in addition to all other rates, be raised, levied, and collected in each year upon all the ratable property in the said Municipality during the said term of twenty years from the coming into effect of this By-law, unless such debentures shall be sooner

paid.

VI. That this By-law shall take effect on, from and after the first day of January, in the year of our Lord, 1860.

VII. That the debentures to be signed and issued as aforesaid shall be delivered by the Mayor of the said City to the Trustees appointed (or to be appointed) in accordance with the tenth section of the said Act incorporating the said Toronto, Grey and Bruce Railway Company.

VIII. And it is further enacted, by the Municipal Counc aforesaid, that the votes of the electors of the said Man cipality will be taken on the said proposed By-law at the following places, that is to say:

For Saint Lawrence Ward at the City Hall in sooms here-fore used as a Police Court.

For Saint George's Ward, at No. 171 King Street west For first electoral division of Saint John's Ward, at the Engine House, Elizabeth Street.

For second electoral division of Saint John's Ward, at the house on Hayter Street, where the last Municipal Election was held.

For first electoral division of Saint Andrew's Ward, at he Bay Street Fire Hall.

For second electoral division of Saint Andrew's Ward, at the Temperance Hall, Brock Street.

For first electoral division of St. James' Ward, at the Police Court, Court Street.

For second electoral division of St. James' Ward, at the house on Yonge Street where the last Municipal Election was held.

For first electoral division of Saint Patrick's Ward, at St. Patrick's Market, on Queen Street.

For second electoral division of St. Patrick's Ward, at No. 438, on the north side of Queen Street, west.

For first electoral division of Saint David's Ward, at the lerkley Street Fire Hall.

For second electoral division of Saint David's Ward, at the house on the north east corner of Parliament and Reech Streets, on the 5th day of December, at the hour of nine o'clock in the fornemoon and closing at five o'clock in the afternoon of the same day.
