P. for a Welsh constituency, has received from Mr. Gladstone a letter in which the ex-Premier says: "Apart from every political question and looking to my sight and hearing, the only choice before me was between resignation and the close of the session and a short continuance of the struggle against difficulties best known to myself. With certainty this struggle must in any case have terminated in the midst of the business session, with much greater inconvenience to everybody interested."

British Parliament. London, March 14.-The House of

Commons was crowded with members and visitors to-day.
Sir William Harcourt announced that the Government had taken advice from a reliable source and had decided to make the declaration that the judgment given last evening in amending the address did not show a mature and well-considered decision of the House of Commons. This was a grave question, he said, and the Government would not present the address as amended to the Queen, consequently the Government proposed to bring up a new address, amounting merely to an acknowledgment

of the speech from the throne. A. J. Balfour, Conservative leader, said the Conservatives would not object to the Government eating its own address. The Opposition had no desire to take advantage of the Government's difficulty, but were prepared to assist in extricating them from their unpleasant position.

Mr. Labouchere, amid cheers and laughter, defended his amendment, the success of which was abundantly justified. It was not intended to hinder the Ministers in regard to these purely formal documents, the Queen's speech and the address in reply

Joseph Chamberlain said the vote of the last evening must either he rescinded or remain in the shape of a vote of want of confidence. The Government ought to dissolve Parliament, and seek a fresh

mandatefrem the country. Sir William Harcourt's motion to rescind the address ar amended, and substitute one merely acknowledging the Queen's speech,

was agreed to without a division. The amendment to the address offered

last night by John J. Clancey (Parnellite) impugning the Government for virtually continuing in Ireland the policy of the late Government was put to a division and rejected, 351 to 15.

The original address was then withdrawn, and Sir William Harcoust formally moved, and John Morley seconded, the new and shorter address acknowledging the Queen's speech. The new address was

adopted without division. Mr. Labouchere, in the course of his remarks defending his amendment to the address which was passed by a vote of 147 to 145, said it was not intended as a vote of want of confidence in the Government, but was merely intended to hasten their action. A majority of the Government's supporters in the country had demanded the abolition of the veto power of the House of Lords, and the Government should take some action in the matter. The Radicals would not oppose a substitute for the address as amended, but would rest satisfied with having done their best, as attested by the majority given his amendment last evening. Continuing, Mr. Labouchere said: "You may withdraw this address and bring in another, but the first one remains the decision of the House of Commons. We are the representatives of the people and the Government are our representatives. I do not recognize that the Government are my masters. I always regarded them as the servants of the majority of the House. Whether you take the majority of the members on this side of the House or the majority of the Liberals outside the House they are with me in this matter and demand prompt, speedy and drastic action. (Radical cheers.) Outside the House they do not care whether you abolish or destroy the House of Lords." Mr. Labouchere was frequently interrupted by cheers and

OTTAWA, March 15 .- This day at 3 o'clock the Governor-General proceeded in state to the chamber of the Senate in the Parliament buildings and took his seat upon the throne. The members of the Senate being assembled, and the members of the House of Commons summoned to the chamber of the Senate, his Excellency was pleased to open the fourth session of the seventh Parliament of Canada with the following speech:

Honorable Gentlemen of the Senate, Gentlemen of the House of Commons:

In the Queen's name I greet you for the first time since assuming the high function entrusted to me by her Majesty, and it is with feelings of liveliest satisfaction that I thus meet you assembled for the labors of another session of Parliament. This feeling of satisfaction is enhanced by the opportunities which I have already enjoyed of visiting, and in my official capacity renewing acquaintances with several of the chief centers of the enterprise and activity of this Dominion. The peaceful conclusion, by the award of the arbitrators at Paris, of the controversy which had prevailed so long, with respect to the seal fisheries in the Pacific Ocean and the rights of British subjects in the Bering Sea, has removed the only source of contention which existed between Great Britain and the United States with regard to Canada. There is every reason to believe that her Majesty's Government will obtain redress for those Canadian subjects of her Majesty who were deprived of their property and liberty without just cause while the controversy was in progress.

At an early date a measure will be laid before you, having for its object a revision of the duties of customs with a view to meet the changes which time has effected in business operations of all kinds throughout the Dominion. While my Ministers do not propose to change the principles on which the existing enactments on this subject are based, the amendments which will be offered for your consideration are designed to simplify the operation of the tariff, and to lessen, as far as can be done consistently with those principles and with the requirements of the treasury, the imposts which are now in force.

There will also be laid before you a measure on the subject of bankruptcy and insolvency, which will, it is hoped, make more adequate provision than now exists on that subject for the increasing trade and commerce of the country, and for the greatly expanded trade between the

several provinces of Canada. Measures will also be submitted to you making more effective provisions for our lines of steam communication on the Atlantic and Pacifie Oceans; for improving the law with regard to Dominion lands and with regard to the management of Indian affairs; also a bill respecting joint stock companies, another with respect to the fisheries, and several less important measures which experience has suggested with regard to various matters under your control.

THE SINGLE TAX

Discussed by the Workingmen in

Messrs. Ashplant. Marks, Hargreaves and Barter Opposed to Henry George's Theory-Mr. Johnston for It-The Opinions Expressed.

The single tax theory as set forth by Henry George was debated in the United Labor Hall on Dufferin avenue, last even-The large audience which listened with interest to the discussion was composed mainly of workingmen, represent-

ing every union in the city. Mr. John Stiling was chosen to act as

MR. H. B. ASHPLANT opened the debate. Mr. Ashplant attacked the single tax theory. In a nutshell it meant a tax on land values only. At the present time the Government had placed taxes on many articles. Liquor was taxed, buildings were taxed, and in the city dogs, too, were taxed. Henry George says: "We already take some rent in taxation. We have only to make some changes in our mode of taxation to take it all. What I therefore propose is the simple yet sovereign remedy which will raise wages, increase the earnings of capital, abolish poverty, lessen crime, elevate morals and intelligence, purify government, and carry civilization to yet nobler heights; and to do all this I propose to appropriate rent for taxation. Taxes may be imposed upon the value of land until all rent is taken by the State without reducing the wages one iota or without increasing the price of a single commodity."

Mr. Ashplant said he could not believe it would bring the benefits claimed. It was in his opinion a huge scheme of spoliation and misappropriation. Henry George had proposed to rob Peter to pay Paul. If a man bought and paid for a lot in London and the single tax came in force shortly after the owner could not realize the price paid. The single tax would create an excitement in the land values for a time. But a temporary excitement caused by a change in the tariff would not be permanent. In New Zealand and other places it was said to have had a good effect. One should wait for the final result. The temporary excitement was not yet over. Take for granted that single tax obtained in Toronto. Some ten or twenty years ago there was a great boom in land values there, but to-day the manufacturing and trading classes were reaping the wealth, while the land owners had houses that they could not rent for a good return. He thought the Patrons of Industry would soon drop the idea of single tax if they passed without amendment. looked further into it. The great trouble of society was under-consumption-starvation on one hand and gluttony on the other. The manufacturers did not overproduce, but the cause of the trouble was the turning of the men out of work, the only true remedy for which should bring equal consumption with production. Single tax could not bring about this remedy; it would increase production, while it would not show how one is to consume what he produces. What was really needed was legislation that would benefit the brotherhood of man. (Applause.)

MR. JOHN JOHNSTON briefly stated himself to be in favor of single tax, but wanted the discussion to spread over two or three evenings in order

that the subject could be given justice. MR. JOHN HARGREAVES. Mr. Hargreaves objected to the name single tax, which was tax on land and land only. He held that it was not right in its basis. According to Henry George, the community has a right to all land. But supposing a government adopted that system, they should be allowed only to expropriate the land to the best interests of the community. Mr. Hargreaves further claimed that when the tax was shifted upon the land only, the taxes had to be paid by the land industry only. Why should the farmer in a new country be taxed for his labors, while the mechanic in the city was not taxed for his labor? The idea of Henry George had been said to abolish monopolies. It might abolish a few but more would crop up-and the opolies. Mr. Hargreaves strongly expressed himself in favor of the Government taking over all street railways, railroads, lighting of streets and coal mines.

MR. JOSEPH T. MARKS, in speaking to the question, quoted from the platform of the Industrial Brotherhood, in which they asked that land, including all the natural sources of wealth, should was wrong to say that single tax or any cutter. other tax was going to remedy the great social problem. The evil does not exist from taxes; it is created by the great system of spoliation. Mr. Marks, in speaking of money making, said that if he wanted to make money he would like to go to Ottawa and be a Cabinet Minister at \$8,000 a year. (Hear, hear.) Then he could put his relations into good situations at good salaries and even send one to the old country. (Hear, hear.) He could not agree with the single tax movement.

MR. THOMAS BARTER could get along with Henry George and his theory until he came to the last conclusion of the author. That was in regard to the nationalization of land, and the Government had never given up its right to take any land back. The theory was, in his opinion, simply another little flag for the boys to float.

When Mr. Barter concluded it was nearly 11 o'clock, and several started for home, among them Mr. Cummings, who had made a statement contradictory to Mr. Ashplant. Mr. Ashplant challenged him to meet him on any platform and dis-

cuss the question. Mr. Keene said that because a person came to make a few remarks it was no reason he should be challenged.

Mr. Cummings-I did not come to debate the question. I simply came to Mr. Johnston-If Mr. Ashplant wants to debate the question on a public platform I am willing to meet him.

LONDON WEST ELECTRIC RAILWAY

Before the Legislators - The Bill Adopted-London's Debt Consolidation Passed.
