In the performance of their duties, the Director, the Deputy Director and the staff shall neither seek nor receive instructions from any Govern ment or from any authority external to the Committee. They shall refrain from any action which might reflect on their position as international officials.

2. Each Member Government undertakes to respect the exclusively international character of the responsibilities of the Director, the Deputy Director and the staff and not to seek to influence them in the discharge of their

responsibilities.

Efficiency, competence and integrity shall be the necessary considerations in the recruitment and employment of the staff which, except in special circumstances, shall be recruited among the nationals of countries whose Governments are Members of the Committee, taking into account, as far as possible, their geographical distribution. 3.
