AIRSTRIP FOR DOMINION HELICOPTERS LTD., KING TOWNSHIP, ONT.

Question No. 812-Mr. Macdonald (Rosedale):

1. Has a departmental investigation been carried out as to the suitability of the location of a single airstrip on the heliport property of Dominion Helicopters Limited in King township, county of York, Ontario, and, if so, what was the result of such investigation?

2. Will the customary departmental approval of the proposed airstrip in advance of construction be

granted prior to December 1, 1962?

3. Has the Minister of Transport or any other minister, received any communication from Mr. Henry Borden, Q.C., of King township, Ontario, as to the location of the airstrip referred to in part 1, and, if so, was such communication oral or in writing?

Mr. Halpenny: 1. Yes. The site was found to be technically suitable for development but objections were received from local property owners regarding the development of an airstrip in that location. In view of this, no action has been taken by the Department of Transport regarding the issuance of an airport licence.

JOINT DRUG TESTING AUTHORITY

Question No. 865-Mr. Badanai:

Has the government given any consideration to the possibility of creating a joint authority with the United States which would regulate the testing and approval of all new drugs, such as is being done in Europe, to prevent the distribution of unapproved drugs across national boundaries?

Mrs. Casselman: No official action has been taken between the two governments but there is and has been close co-operation between the departments of government concerned in the interchange of information relating to new drugs and to reports of undesirable side effects or other dangers. In a more general context, however, it should be noted that in May of this year, Canada co-sponsored a resolution approved by the world health assembly, in which the director general was requested to study the feasibility of increasing international co-operation in this field, under world health organization auspices. The study is now in progress, and will be followed closely by Canada's representative on the executive board.

LIGHTHOUSE BUILDING, POMQUET ISLAND, N.S.

Question No. 884-Mr. Stewart:

the crown assets disposal corporation advertised for sale and removal the lighthouse building on Pomquet island, Nova Scotia, was it stipulated that the purchaser was to fill in the cellar excavation?

Mr. O'Hurley: Advertisement bore the notation that the buildings were being sold "for removal and restoration of sites" and invitations for offers stated that "within 60 days from the date of sale the purchaser shall demolish and remove the buildings and all materials and leave the sites clean and tidy after levelling to the original elevation of the ground any excavations or mounds resulting from the original construction or the demolition".
