VIOLENT DISTURBANCES

REQUEST FOR INVESTIGATIONS BY R.C.M.P. OF MONTREAL BOMBING

Mr. Gilbert Rondeau (Shefford): Mr. Speaker, I should like to put a question to the Prime Minister.

A few years ago the federal government and the R.C.M.P. launched an investigation which led to the discovery of the FLQ movement and of certain separatists responsible for bomb explosions. Now is the federal government ready to act with the same firmness and stubborness in order to find out if some Maoists, as we have heard, are responsible for this wave of terrorism which we have been experiencing in Quebec during the few last months?

Right Hon. P.-E. Trudeau (Prime Minister): Mr. Speaker, I wish to say to the hon. member that the government shares his concern and that I have discussed this problem with the Solicitor General who is doing his duty in that connection.

We have naturally taken for granted that the police both of the City of Montreal and the Province of Quebec are the first responsible in the field and have been doing an excellent job. We are offering them all the co-operation they wish for.

That help has been available, is available, and is being used from time to time as the occasion requires.

Mr. Paproski: Mr. Speaker, will the government not accept some responsibility for [Mrs. MacInnis (Vancouver-Kingsway).] investigating organized anarchy, or must we wait until someone is killed?
