INTRODUCTION OF LEGISLATION BASED ON WHITE PAPER ON TAX REFORM

Mr. Gordon Ritchie (Dauphin): I have a question for the Minister of Finance. In view of the great uncertainty on the part of business and commerce and their plans for future expansion as a result of the white paper on taxation, when does the minister expect to introduce legislation for tax changes based on that document?

Hon. E. J. Benson (Minister of Finance): In the spring budget, Mr. Speaker. I might clarify my answer. The spring budget will include tax reform but not necessarily the entire contents of the white paper.

HOUSING

ACTION TO INCREASE CONSTRUCTION OF PUBLIC HOUSING
—INCENTIVES IN NEWFOUNDLAND

Mr. Jack Marshall (Humber-St. George's-St. Barbe): I have a question for the Minister without Portfolio in charge of housing. While statistics indicate progress in housing starts in the low-cost sector, will the minister advise if anything is being done in co-operation with the provinces to step up production in the area of public housing where the needs remain acute in many parts of the country?

Hon. Robert K. Andras (Minister without Portfolio): During 1969 and 1970 the federal commitment to public housing will have had the effect of doubling the whole stock of public housing in two years compared with the previous activities of some 25 years. That emphasis will continue into 1971 and beyond. In addition, we have offered to the provinces of participation the idea of acquiring from existing stock through long-term lease accommodation for which we will share in terms of public housing subsidies. In this way, they will be in the position of not having to wait for new building production or provide capital investment.

Mr. Marshall: In view of the high cost of construction in the province of Newfoundland, which is causing delays in providing this type of housing, will the minister consider incentives for the construction industry in the province in order to create an impetus to overcome the serious shortage?

Mr. Andras: Mr. Speaker, we embarked on that in an exploratory way this year. We will certainly continue discussions with the provincial government of Newfoundland and any members of the industry who are willing to sit down with us to see what can be done in this field.

Mr. John Gilbert (Broadview): A supplementary question. Does the minister think that spending 60 cents per capita on public housing is sufficient to meet public housing needs?
