

The commission believes that there is room in the non-Canadian portion of the television schedule for recognized, quality, educational programs, and it is their expectation that Canadian broadcasters should develop and present far more Canadian educational programs of high quality. If, however, special status is accorded to non-Canadian educational programming, then the commission feels that Canadian broadcasters will be encouraged to import more of such programs without developing Canadian programs of comparable quality.
