- Hon. Barney Danson (Minister of National Defence): 1. Canex (Canadian Forces Exchange System) is a system of retail sales outlets operated on Canadian Armed Forces bases, stations and ships for the benefit of military personnel and their families.
- 2. Operations are under the direct control of a Board of Directors shared by the Chief of Defence Staff.
- 3. Retail Stores, 66; Supermarket/Groceterias, 60; Service Stations/Gas bars, 70; Cafeteria/Snack bars/Canteens, 55; Vending Operations, 35; Total, 286.
- 4. To provide detailed data on volume, expenses, profits etc. for each of the above unit outlets would require researching hundreds of financial statements all over Canada and overseas for which the department does not have the necessary resources. However, volume and profit for the total Canex operation was as follows:
