EXTENSION OF STATUTORY GRAIN RATES TO TRITICALE

Hon. John M. Reid (Kenora-Rainy River) moved for leave to introduce Bill C-634, to amend the Railway Act (rates on triticale).

Some hon. Members: Explain.

Mr. Reid: Madam Speaker, the purpose of this bill is to add triticale and triticale flour to the list of cereal grains which have the benefit of the Crow rate. Triticale and triticale flour do not have that status at the present time and are unable to compete with other grains that do have it.

Motion agreed to, bill read the first time and ordered to be printed.

Mr. Jack Murta (Lisgar) moved for leave to introduce Bill C-635, to amend the Railway Act (rates on triticale).

Some hon. Members: Explain.

Mr. Murta: Madam Speaker, my bill is virtually identical to the previous one. The purpose is to include triticale, which is a bread and feed grain of a very high yield, in the Crowsnest Pass rate so that it may be sold in our export markets under the same competitive conditions as wheat.

2. Was Mr. Gerald McKee a senior employee of the Post Office Department at any time that RPR Associates Ltd. received such contracts?

3. Did Mr. McKee terminate his services with the department or were his services terminated by the department and, if so (a) on what date (b) for what reason?

4. To the knowledge of the government, was Mr. McKee an employee of RPR Associates Ltd.?

5. Was any branch of government approached, directly or indirectly, for business for Gerald McKee Enterprises or for Gerald McKee and, if so, what are all the details?

6. Is it the intention of the government to appoint Gerald McKee to the Public Service and, if so, to which position and department?

7. Has Mr. McKee applied for a position in the Public Service?

8. Will any government decision in regard to Gerald McKee or Gerald McKee Enterprises be in any way based on the fact he was a Liberal Party candidate in Leeds-Grenville in the general elections in 1979 and 1980?
