# DEPARTMENT OF VETERANS AFFAIRS—DECENTRALIZATION TO PRINCE EDWARD ISLAND

### Motion No. 1-Mr. Cossitt:

That an order of the House do issue for copies of all correspondence, notes, minutes of meetings and other communications relating to the decentralization of the Department of Veterans Affairs to the Province of Prince Edward Island.

Mr. D. M. Collenette (Parliamentary Secretary to President of the Privy Council): Madam Speaker, the Minister of Veteran Affairs would ask that the hon. member from Grenville-Carleton withdraw the motion on the grounds that the total volume of papers is such that the expense, in time and personnel, of producing them would be extremely high. As well, some of these documents involve the government of Prince Edward Island, and that government's consent would have to be obtained prior to their tabling. However, the minister does invite the hon. member to visit the department, and the minister undertakes to make available to the hon. member all possible material.

Mr. Tom Cossitt (Leeds-Grenville): Madam Speaker, first I would like the record to show that my riding is Leeds-Grenville, and not Grenville-Carleton as mentioned by the parliamentary secretary.

Why I must ask that this matter be transferred for debate is as follows. While I may be able to go and look at the material, the people of Canada and members of the Canadian Legion, in particular, who are highly interested in this subject, as all members know, are not going to be able to look at the material. There is nothing secret about the documents. It is the old excuse that it costs too much money, and we have heard that too often. I feel that it should be transferred for debate, and that the members of this House should have an opportunity to talk about it.

**Madam Speaker:** Hon, members have heard the proposition that the motion be transferred for debate. Is it agreed?
