#### PURCHASE OF BRITISH PETROLEUM COMPANY

It adds \$347 million in a negative way to our international balance of payments and will not result in the creation of one single new job. Therefore I move, seconded by the Hon. Member for Calgary North (Mr. Wright):

That, if the Finance Minister truly believes that the private sector is the engine of growth, he cease and desist his socialist takeovers, and if Petro-Canada has \$347 million to play around with, that it use it to retire the billions it owes the Canadian taxpayer in debt and stop meddling in the private sector.

### EL SALVADOR—CONDEMNATION OF KIDNAPPINGS BY SECURITY FORCES

**Mr. Bob Ogle (Saskatoon East):** Madam Speaker, I rise on a matter of urgent and pressing necessity. On October 18, 19 and 20, in the capital of El Salvador, 15 moderate trade union and political leaders belonging to the FDR were kidnapped on the street or at their place of work. In view of the Annual Report published last week by Amnesty International citing the fact that the Government of El Salvador was not able to provide even one satisfactory explanation in the 555 cases of persons detained in the last year, I move, seconded by the Hon. Member for Selkirk-Interlake (Mr. Sargeant):

That this House condemn the use of kidnapping by security forces in El Salvador, and that this House urge the Government of Canada to press the Government of El Salvador to secure the immediate release of the 15 kidnap victims.
