In fact, the only product Colgate–Palmolive will continue to make in Canada is Colgate dental cream.

There is a message in this for all of us who are truly concerned about plant closings and manufacturing job losses. Buy Canadian. Clean your teeth with Colgate dental cream but do not wash with Palmolive soap.
