Oral and Written Composition:—The work of Part I continued and developed. **NARRATION**—covering fables, legends, fairy tales, incidents, simple biographies,—based on models, pictures, summaries; structure of narration. **DESCRIPTION**—familiar scenes, natural phenomena,—based on observation, models, pictures. **LETTER-WRITING**—familiar and business letters. **BUSINESS FORMS**. **EXPOSITION**—familiar nature themes. **EXERCISES**—on homonyms, antonyms; combining sentences; variation of expression—direct and indirect narration.
