

On motion of the Honorable Mr. Solicitor General *Langevin*, seconded by the Honorable Mr. Solicitor General *Cochburn*,

*Resolved*, That this House will, at its first sitting on Thursday next, resolve itself into a Committee to consider the following proposed Resolution :—

*Resolved*, That instead of the appropriation and distribution of the Provincial Aid according to the 15th chapter of the Unconsolidated Statutes for *Lower Canada*, the following appropriation and distribution be made take place, and be a charge on the revenues of that part of the Province of *Canada* known as *Lower Canada*, when it becomes a separate Province, and have a separate Government; and be then in lieu of the several appropriations now made by said chapter, viz. :—

The Provincial Aid for Education purposes in *Lower Canada* shall be Three hundred thousand dollars, and appropriated as follows :—

1. A sum of Forty-five thousand dollars for Superior Education ;
2. A sum of Thirty thousand dollars for Normal Schools and their Building Fund ;
3. A sum of Thirty thousand dollars for Academies ;
4. A sum of One hundred and seventy-three thousand dollars for Model and Common Schools, and other expenses required by chapter fifteen of the Consolidated Statutes for *Lower Canada*, and not above or hereafter mentioned.
5. A sum of Twenty-two thousand dollars for salaries and contingencies of the Educational Department.

The House, according to Order, again resolved itself into a Committee on the Bill to amend an Act respecting the Volunteer Militia Force ; and after some time spent therein, Mr. Speaker resumed the Chair ; and Mr. *Jones* (South *Leeds*) reported, That the Committee had gone through the Bill, and made further amendments thereunto.

*Ordered*, That the Report be now received.

Mr. *Jones* (South *Leeds*) reported the Bill accordingly, and the amendments were read, and agreed to.

*Ordered*, That the Bill be read the third time, on Thursday next.

The Order of the Day for resuming the further consideration of the second Resolution reported from Committee of Ways and Means on Friday last, being read ;

*Ordered*, That the said Order be discharged.

Mr. *Biggar* reported, from the Committee of the whole House, to consider a certain proposed Resolution relative to the appointment of a Registrar for the Judicial District of *Nipissing*, a Resolution, which was read, as followeth :—

*Resolved*, That the Governor in Council may appoint a Registrar of Deeds to the Judicial District of *Nipissing*, who shall register all Deeds and other Conveyances and Agreements relating to lands situate in any part of the said Judicial District, and laid out and surveyed by the Crown ; that his fees shall be the same as those appointed by the Laws of *Upper Canada* respecting the registration of Instruments ; or the Governor in Council may order an annual Salary, not exceeding eight hundred dollars, to be paid to the Registrar, out of the Consolidated Fund, in lieu of such fees ; which fees, in such case, shall be paid into such revenue.

The said Resolution, being read a second time, was agreed to.

*Ordered*, That the said Resolution be referred to the Committee of the whole House on the Bill, from the Legislative Council, intituled, " An Act to amend chapter 128 of the " Consolidated Statutes for *Upper Canada*, intituled, ' An Act respecting the Administration of Justice in the unorganized tracts.' "
