(if course we do not know what the present month and March have in store for us, but if

they in any way resemble December and January, the present winter will without doubt be the most severe within the memory of man. We believe that the month just ended has been unprecedented for its low temperature and numerous heavy snow

storms; and therefore it is very unlike the ideal which some persons have set up for themselves on the belief that our winters are growing milder We have no doubt that .if we had tables of the temperature for one hundred years . back it would be

shown that very little change has taken place in the climate of New Brunswick. There may be a some what smaller rainfall in consequence of so much of our forest being cleared away, but even this is open to doubt.

What is quite certain is that with regard to temperature there is practically no difference between the old winters and those we are having in recent years. This is shown by the table of the opening and closing of Allen Russell, John Campbell, Thomas the St. John River since the year 1825. To the ming of 1902 the river opened in March for the first time on record but it may be a century before such a phenomenon is seen again. On seven occasions




