EARLY IMPLEMENTATION OF MEASURE-DISMISSAL OF COMMISSIONAIRES FROM MUSEUMS

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, I should like to ask the Prime Minister whether the Clerk of the Privy Council last October, as has been revealed by the secretary general of the National Museum, issued a memorandum urging the early implementation of the terms of the official languages bill and, if so, under whose or what authority was this done?

Mr. Speaker: In view of the fact the hon. member is referring to an incident which is alleged to have happened last October I doubt whether there is urgency to the question. If there is urgency, and it is certainly not apparent to me, and if the Prime Minister feels it can be answered, I have no objection.

Mr. Dinsdale: Mr. Speaker, if this cannot be dealt with as a question on orders of the day, perhaps I could deal with it as a question of privilege. As we all know, the official languages bill has not yet been dealt with by this house, and if there are memoranda going held any meetings with the provincial health out from official sources this must be under ministers or the Canadian Medical Association 29180-2993

somebody's authority, for it certainly does not have the authority of parliament.

Right Hon. P.-E. Trudeau (Prime Minister): Mr. Speaker, perhaps I could be helpful. After the official languages bill was introduced in this house for first reading in October the Clerk of the Privy Council under my authority did write to various departmental heads to suggest that, in keeping with the government's desire to plan ahead, they take certain preparatory steps toward the day when they would have to implement such an act. There was no direction given for any specific action, but just an indication that provisions should be under way, so that when action was required the departments would be in a position to take it.

Mr. Dinsdale: Mr. Speaker, the secretary general of the National Museum indicated that action was taken with reference to commissionaires.

Mr. Trudeau: That may have been the statement by the gentleman in question, but this was not under government direction.
