In March of 1954 Mr. Gilles Sicotte, then an officer of the Department of External Affairs, wrote a personal letter to a Mexican immigration official seeking clarification of Mrs. Sicotte's status as a visitor to Mexico. Some months later Mr. Sicotte telephoned the same official, again in a personal capacity, requesting permission for Mrs. Sicotte to reenter Mexico for continued medical treatment in that country; (e) Yes. Investigations were made into Mrs. Gilles Sicotte's activities in and the reasons for her leaving Mexico. In particular, inquiries were made of Mr. Arcadio Ojeda.

They were not successful in serving her. Again on October 7, 1968 our legal agents in Ottawa were given further instructions to serve Mrs. Sicotte with the process.
