paign to support, as I believe the newspapers put it, the budgetary measures of the Minister of Finance.

Mr. Fairweather: A million dollars would not be enough for that.

Mr. Trudeau: After the bill has been discussed and hopefully passed by the House and becomes law there is provision not for the Department of Finance but for the Department of National Revenue to conduct a campaign to explain to the taxpayers how the new tax law—

Mr. Fairweather: Explain to the taxpayers how to make out their tax forms.

Mr. Trudeau: Well, Mr. Speaker, I see the opposition is not interested in knowing how the taxpayers' money is spent.

Mr. Crouse: Neither are you.

## CANADIAN CONSTITUTION

JURISDICTION OVER SOCIAL SECURITY AND WELFARE— UNDERSTANDING BETWEEN PRIME MINISTER AND PREMIER BOURASSA FOLLOWING DISCUSSIONS

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, may I direct a question to the right hon. Prime Minister with reference to the question of the constitutional jurisdiction over social security and welfare. Can the Prime Minister say whether in his discussions with Premier Bourassa he and the Prime Minister of Quebec have come to any understanding?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I can truthfully answer that question only after the event. I cannot say now whether there will be an understanding reached in Victoria or not. I hope that as a result not only of my meetings with the premier but the meetings of the Minister of Justice of Canada with the premiers and Attorneys General of all the provinces in the past several months there will be an understanding in Victoria.

TRANSFER OF FORD FOUNDRY OPERATION AT WINDSOR TO FLAT ROCK, MICHIGAN

Mr. H. W. Danforth (Kent-Essex): Mr. Speaker, I should like to direct this question to the Minister of Industry, Trade and Commerce; it is not the same question that was dealt with on Tuesday. Has there been any discussion between his department and Ford Motor Company of Canada with regard to the phasing out of their Windsor foundry and the transfer of this work and the jobs to their new plant at Flat Rock, Michigan, and is his department discouraging such a move?

OVERSEAS STUDENT EXCHANGE PROGRAM—APPLICATIONS RECEIVED AND APPROVED

However, I intend to inform the House of this distribution when we reach the end of the funds earmarked for this program so as to avoid any misunderstanding; the House will thus be in a position to assess the balance of this distribution according to the criteria set up when this program was initiated.
