#### DEVELOPMENT LOAN TO TURKEY

Question No. 2,047-Mr. Robinson:

1. Has a five million dollar development loan been advanced to Turkey and, if so, is it being spent under the framework of the Organization for Economic Cooperation and Development?

2. What is the repayment arrangement?

3. What is the interest rate on the loan?

Hon. Mitchell Sharp (Secretary of State for External Affairs): 1. A five million dollar development loan was pledged to Turkey in 1969 by Canada as a member of the OECD aid consortium for Turkey. It is not being spent under the framework of OECD, though that Organization is kept fully informed of developments regarding the planned utilization of the funds.

2. Repayment in 30 years, with an initial grace period of seven years.

3. The interest rate is three per cent.

## UNEMPLOYMENT INSURANCE COMMISSION— COLLECTION OF OVERPAYMENTS

### Question No. 2,065-Mr. Hales:

1. Does the Unemployment Insurance Commission have a collection department for outstanding debts or overpayment to claimants?

2. What is the total amount of these receivables?

3. What were the amounts for each of the years 1965, 1966, 1967, 1968, 1969 and 1970?

4. What are the amounts outstanding that fall into the following classifications (a) 1-2 months (b) 3-6 months (c) 6-12 months (d) 1 year (e) 2 years (f) 3 years (g) 4 years (h) 5 years?

5. What means are used to collect these debts?

6. Is an accounts receivable balance system used?

**Hon. Bryce Mackasey (Minister of Labour):** 1. The Unemployment Insurance Commission has a collection section in each district office with responsibility for collection of overpayments of benefits to claimants.

2. The total amount of receivables relating to overpayment of benefits to claimants at March 31, 1971, was \$5,687,199.

4. The Commission's Accounts Receivable system records the outstandings on a quarterly aging process and the balances for March 31, 1971, were as follows: (a) Less than 3 months, \$1,088,319; (b) 3-6 months, \$786,963; (c) 6-12 months, \$878,543; (d) 1 year, \$1,159,780; (e) 2 years, \$553,-044; (f) 3 years and over, \$1,220,550; (g) 4 years, N/A; (h) 5 years, N/A.

Note: Figures for four years and five years are not kept separately.

5. Collection procedures begin by contact with the claimant by letter, requesting payment or arrangements for repayment. If the claimant does not respond to such requests, facts are gathered on the claimant's ability to repay and further collection action is taken as considered appropriate in each particular case. If the claimant files a new claim, any outstanding overpayment is collected from any benefits which may become payable.

6. A system for recording of the balance for each account receivable is maintained.

#### DRUGS—CHARGES FOR INDICTABLE OFFENCES WHILE UNDER INFLUENCE OF DRUGS

### Question No. 2,075-Mr. Yewchuk:

For each year 1964 to 1970, how many (a) males (b) females in the age groups 16-24 and 25-44, and under the influence of hallucinogenic drugs, were charged and convicted of indictable offenses (i) against the person (ii) against property with violence (iii) against property without violence (iv) malicious offences against property?

Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): The Department of the Solicitor General, the Department of Justice and Statistics Canada do not have at its disposal any records which would indicate whether or not an accused person was under the influence of a drug during the commission of any of the offences referred to in Question number 2,075 above.
