## COMMITTEE STUDY OF AHOP MORTGAGE DEFAULTS—MOTION UNDER S.O. 43

**Mrs. Jean E. Pigott (Ottawa-Carleton):** Mr. Speaker, I rise, under the provisions of Standing Order 43, on a matter of urgent and pressing necessity.

In view of the fact that the Minister of State for Urban Affairs has indicated that the default rate under the AHOP program is probably around 5 per cent, involving approximately 5,000 households, a figure which includes all AHOP purchasers, and since the candidates most likely to be in a default position are the initial purchasers in 1973 and 1974, the figure of 5,000 householders more accurately represents a default rate of 20 per cent, I would move, seconded by the hon. member for Selkirk (Mr. Whiteway):
